THE HONOURABLE JUSTICE MELISSA PERRY was appointed to the Federal Court of Australia on 23 September 2013. Since 2011, Justice Perry has served as an Officer with the Royal Australian Air Force, and has since been promoted to Air Commodore. Justice Perry is the Deputy Judge Advocate General, Air Force, holding office on a part-time voluntary basis. Her doctorate on State succession, boundaries and territorial regimes was awarded the Yorke Prize by the University of Cambridge. Justice Perry is a Fellow and former Director of the Australian Academy of Law, and a member of the Advisory Committee to the Gilbert + Tobin Centre of Public Law, University of New South Wales; the Law School Advisory Board and the Research Unit on Military Law and Ethics, University of Adelaide; the Advisory Board, Centre for International and Public Law, Australian National University; and the Advisory Board, UNSW Allens Hub for Technology, Law and Innovation.

ANNE HEALEY has over 30 years' experience as an advocate in both criminal and civil cases, in inquests and inquiries, and through mediation and other forms of alternative dispute resolution. She appears for both the prosecution and defence in criminal proceedings and is a member of the Legal Aid Specialist Barrister Panel (Complex Criminal Law) and the Criminal Appellate Panel. She has been appointed to the NSW ODPP and CDPP Private Briefing Panels. Anne also has extensive experience in personal injury matters. She has been appointed to the Panel of Civil Mediators for the ACT Supreme Court and the criminal Case Convenors Panel for the ACT Supreme Court.
